Dear Chief Financial Officer:

This letter serves to confirm our receipt of your initial registration application packet and to issue your organization a charitable registration number which is: CH3393800. Please keep this letter in your permanent files for easy future access to your NJ Charitable Registration number. Pursuant to the Charitable Registration and Investigation Act (N.J.S.A. 45: 17A-18 *et seq.* known as the CRI Act), you may assume that your Charitable Registration application has been accepted within (10) business days of this letter. On the tenth day after the date of this letter, you may refer to the above charitable registration number and proceed as an organization registered to solicit funds in this State.

Please note that your initial registration is still under review. If your application is found to be incomplete, you will be notified and a prompt remedy to the deficiency is expected. If your organization does not take steps to remedy the deficiency in a timely manner, your Charitable Registration number will be revoked and it will be unlawful for your organization to solicit funds in this State.

Once the initial registration is completed, your registration number will remain the same from year to year. Your registration number should appear on any and all correspondence, registration renewals and/or documents sent to this office. Payment of registration & late fees must be in the form of check or money order, made payable to the "NJ Division of Consumer Affairs", with clear indication of the charitable registration number and fiscal year(s) end for which payment is being made.

The CRI Act requires charities to renew their registration annually by filing a renewal registration form and registration fee, along with a copy of the IRS 990 filed and a certified audit (if total gross income exceeds \$250,000). Annual renewal registrations are due within the six (6) months after your organization's fiscal year end. If the annual renewal registration is submitted late, a \$25 late fee is due in addition to the registration fee.
